OVERVIEW

Definition: Civic league or organization not organized for profit but operated exclusively for the promotion of social welfare.

The Proponent will be assessed on six areas:

- 1. Vision, Mission, Goals
- 2. Governance
- 3. Internal Management
- 4. Program Operations
- 5. Financial Management
- 6. Collaborative Linkages

1. Vision, Mission and Goals (VMG)

- The NGO is engaged in development work in the PhilippinesClarity of purpose, sector served and functions in its pursuit of a public good
- Priority is given to NGOs that focus on youth, LGBTQIA, women, and displaced populations
- Common understanding of the VMG by Board Members, Management, Staff, Beneficiaries and Partners
- Degree to which the VMG are achieved

2. Governance

- Active involvement of Board Members in:
 - Policy formulation and direction setting
 - Approval of strategic plan and budget
 - Evaluation of program accomplishments and financial performance
 - Resource generation for sustainability
- Compliance with legal requirements of concerned government agencies
- Delineation of responsibilities of the Board and Executive Officer



3. Internal Management

- Clear inter-relationships and delineation of duties and responsibilities and authorities of staff
- Sufficiency of staff and appropriateness of knowledge, skills and attitudes
- Compliance with government labor and employment laws
- Written and practiced administrative and personnel guidelines

4. Program operations

- Mechanism for involvement of stakeholders
- Criteria for selection of beneficiaries and programs and services
- Program guidelines are in place and practiced accordingly:
 - o Planning
 - Implementation
 - Monitoring and Evaluation
- Tracking of program disbursements

5. Financial Management

- Presence annual budgets
- Financial internal control guidelines applying checks and balances in handling and utilization of funds
- Proper maintenance of updated books of account duly registered with the Bureau of Internal Revenue
- Annual external audit by independent Certified Public Accountant registered with the Professional Regulatory Board and Board of Accountancy
- Regular sources of funds
- Reporting to stakeholders of funds generated and corresponding utilization

6. Collaborative Linkages

- Resource generation plan
- Criteria and system for partnering
- Program partnerships with other institutions (NGOs, Funders)
- Sharing of "good practices"

Disclosure of related business, if any, and extent of ownership

Work and Financial Plan and sources and details of equity

Detailed proposal signed and approved by its officers which shall include objectives, target beneficiaries, feasibility studies, risk assessment, design, among others
